### Memorandum of Understanding

Entered Into Between

#### CertainTeed Corporation, Insulation Group And Residential Energy Services Network

#### 1. <u>Purpose</u>

CertainTeed Corporation, Insulation Group (CertainTeed) and the Residential Energy Services Network (RESNET) hereby enter into this Memorandum of Understanding (MOU) to promote the improvement of the home energy performance process in the United States. This MOU outlines how the two parties plan to work together to achieve the goal of this MOU.

#### 2. <u>Goal of the MOU</u>

The goal of this MOU is to provide an outline of how CertainTeed and RESNET will develop and implement improvements to the home energy performance process in the United States.

#### 3. <u>Terms of the MOU</u>

CertainTeed and RESNET will continue this relationship as long as they mutually believe it is beneficial for both organizations to work collaboratively on accomplishing the goals of this MOU.

- 3.1 RESNET will provide CertainTeed with a breakout session for CertainTeed to speak about the importance of specifying the correct insulation material when recommending insulation upgrades to home owners at the 2012 RESNET Building Performance Conference.
- 3.2 RESNET will assist CertainTeed in encouraging networking between insulation contractors and RESNET auditors.
- 3.3 CertainTeed and RESNET will develop a marketing and implementation plan for a CertainTeed Utility insulation program.
- 3.4 CertainTeed and RESNET will jointly promote the CertainTeed Utility insulation program as a solution for utility company energy efficiency programs.

- 3.5 CertainTeed will encourage its contractor customers to participate in the Energy Smart Contractor training program.
- 3.6 RESNET will develop marketing literature with input from CertainTeed for the promotion of the Energy Smart Contractor Training Course. This literature will then be distributed by CertainTeed to its contractor customers.
- 3.7 CertainTeed will assist RESNET and other groups in developing a process that is recognized by DOE and EPA for the Home Performance with ENERGY STAR Homes program, and other federal retrofit efforts enacted by the United States Congress or State programs.
- 4 Administration of the MOU
- 4.1 CertainTeed and RESNET will identify contact person(s) to monitor and assess the implementation and application of the MOU within their organization. Questions, disputes and inquiries will be fielded by the identified individuals.
- 4.2 CertainTeed and RESNET agree that this MOU is a dynamic and evolving instrument that will be reviewed by both organizations at least annually after 2011.
- 4.3 CertainTeed and RESNET agree that if either party, in its own assessment, believes that the MOU is no longer supporting their company's best interests, each organization will have the right to terminate this MOU upon providing the other party with 90 days prior written notice.
