MEMORANDUM OF UNDERSTANDING

Between

Structural Insulated Panel Association and

Residential Energy Services Network

1.0 Purpose

The Structural Insulated Panel Association (SIPA) and the Residential Energy Services Network (RESNET) enters into this Memorandum of Understanding (MOU) in order to promote the improvement of home energy performance in the United States. It spells out how the two organizations will cooperate to meet this goal while assisting the growth of both organizations and their membership.

2.0 Goal of the Agreement

The goal of this MOU is to lay a framework of a long, mutually beneficial relationship between SIPA and RESNET.

3.0 Terms and Conditions of MOU

The following are the areas where SIPA and RESNET agree to cooperate:

3.1 <u>SIPA Presence at the 2012 RESNET Building Performance Conference</u> – RESNET will comp SIPA a booth at its trade show at the 2012 RESNET Conference. RESNET will also schedule a one and half hour break out session for SIPA to present on SIP-related topics relevant to conference attendees.

- 3.2 RESNET Presence at the 2012 SIPA Annual Meeting & Conference SIPA will comp RESNET with exhibit space at the 2012 SIPA Annual Meeting & Conference trade show and will be offered one half hour presentation on the meeting agenda.
- 3.3 Having SIPA Representative Serve on RESNET Technical Committee's

 Insulation Industry Advisory Council RESNET has formed an Insulation
 Industry Advisory Council to its Technical Committee. This committee will
 recommend proposed amendments to the RESNET technical standard as well as
 review proposal from the Technical Committee dealing with insulation issues.
- 3.4 <u>SIPA will Communicate Opportunities to be designated by RESNET as an EnergySmart Contractor to its Members</u> RESNET will work with in drafting a marketing piece introducing the RESNET EnergySmart Contractor designation. SIPA will assist is distributing the information to its members.
- 3.6 <u>Collaboration on Advocating Federal Incentives for Energy-Efficient</u> <u>Construction</u>– SIPA, RESNET and other groups will participate in an industry coalition for the advancement of tax incentives for new energy-efficient construction and energy-efficient retrofits for both homes and commercial buildings, such as the Advanced Energy Tax Incentives Act, HOME STAR, and others.

4 Administration of the Agreement

- 4.1 Each *organization* agrees to identify a contact person(s) to monitor and assess implementation and application of the agreement within their *organization* and to address inquiries, disputes or questions arising from the implementation of the agreement.
- 4.2 Each *organization* agrees that this agreement is a dynamic and evolving

instrument that may be amended with the consent of both *organizations*. The *organizations* agree to initiate periodic reviews of this agreement every year after 2011, and the operation of the agreement when such request is made by one of the *organizations*.
