#### RE 134-16

Performance trade off method- proposed by NAHB to allow for a trade off by HVAC systems Now involved in 301 discussions- one proposal would be removed if RESNET supported the equipment trade off provision

David Goldstein made a motion to support amendment RE 133-16 if a deal is made to remove the amendment to 301. If a deal does not take place RESNET would remain neutral. Kelly Stephens seconded the motion. Brett Dillon abstained. Motion approved by voice vote.
